This included the sale of the regional business, which was completed on October 31, 2010. As previously communicated, Cargojet will be converting from an income trust to a common share corporation, Cargojet Inc. (TSX: CJT) on January 01, 2011. This move is the correct plan for Cargojet and was voted upon and approved by all unitholders and passed at our Annual General Meeting earlier this year.

In February of this year, we celebrated Cargojet's 8th year anniversary of the brand. As many of you are aware, we have been around a little while longer than that! What an exciting journey these past number of years have been for all of us. Let me thank our entire team for making Cargojet a true success story in the Canadian Aviation and Air Cargo business. In the Spring of 2010, Cargojet successfully recertified its ISO 9001:2008 Quality Standard Accreditation for the 10th consecutive year. Cargojet surpassed expectations in the industry in key areas of on-time performance, customer service, quality of equipment & operations, competitive pricing and leaders in problem solving. Our on time performance levels continue to exceed 98.7%. This award is a testament of the dedication and loyalty of our team members. We are also fully compliant with Stage IV of the Transport Canada Safety Management System program and recently successfully completed our Program Validation Inspection.

"SMS UPDATE"

To provide you an update on the Safety Management System for 2010 we need to compare our numbers to previous years, and look for safety culture indicators. The most important indicator to date is the fact that 98% of all reports are closed within 90 days. It shows the commitment the organization has put on Safety, and the development of the Safety Managers in the organization. Breaking the data down into departments, Flight Operations, Maintenance and Commercial handle the majority of issues reported. It is important to recognize the efforts of the Safety Team, including Mariana de Volpe, Mark Harper, Glenn Simard, Paul Martin, Chris Ryan, Jason Allen, and Mike Cancela, for their great efforts in dealing with the day-to-day activity.

We have added Online Reporting, and staff will be getting individual User Names and Passwords that will allow them to submit a report from any computer with internet access via www.cargojetsafety.com. This will provide us with the opportunity to become a greener organization and move to paperless reporting.

We will be renewing our IOSA Certification in 2011 and this preparation is being handled through the Regulatory Review Sub Committee (RRSC) that met on November 4th in Hamilton.

You will notice in all Stations that we have standardized the Safety Boards and its content. It is updated quarterly with packages sent to the Station representatives. The Safety Website has been updated to provide more current information on SMS and access to Safety Reporting through Q-Pulse. Please take an opportunity to visit the new site.

The organization's Safety Goals were to provide online reporting; reduce operational impact incidents, and increase safety awareness at all levels in the organization. On the SMS Website we have a tab that will provide you with an update on the status of those objectives. Please take a moment and visit the site to review status updates.

Cargojet Security has been very busy this year with the many challenges of ensuring a secure supply chain is in place at all our known shippers. Transport Canada and Department of Homeland Security (DHS) in the US are constantly upgrading these standards via regulatory amendments and precautionary measures. The revised SMS Training, making its way around the company, highlights the Security requirements for Cargojet staff of remaining vigilant to all security hazards. These are just a few items we have worked on this year, and you can look on the web site for more details on Safety and Security.
